# NOW THAT YOU ARE PLANNING TO BE A STUDENT OF THE LEAGUE'S CERTIFICATE PROGRAM, THERE ARE TWO THINGS YOU CANNOT DO!

#### 1. DO NOT ENTER THE U.S. WITH A B-1, B-2, OR B-1/2 VISA

If you use a B visa to enter the U.S. you are saying "I'm here as a visitor" *only*. Since you contacted our school about study in the League's Certificate Program, this could be viewed as misrepresenting your purpose for entering the U.S. and you might be refused permission to extend or to change your status. Do <u>not</u> listen to people who say it is easy to enter the country as a visitor and change your status to F-1 Student. It is not true! U.S. federal regulations prohibit B Visitors from pursuing a course of study prior to obtaining a change of status to F-1 Student.

If your study plans are not certain and you want to enter the U.S. to visit schools, you must explain this on your visa application and ask the visa officer for a B-2 visa with the words "Prospective student" noted on it or have the words added to your B visa if you already have one.

#### 2. DO NOT ENTER THE U.S. on the Visa Waiver Program (Waiver Tourist or Waiver Business)

If you are from a country from which you can enter the U.S. as a visitor by registering for ESTA, do not do this. You will be permitted to stay for only 90 days. You will not be given more time or allowed to change to F-1 Student status.

#### WHAT IS A FORM I-20 AND WHY DO YOU NEED ONE?

A Form I-20 is a government form that certifies you are eligible for F-1 Student status. That means that (1) you are or expect to be a "bona fide" student; (2) you meet our admissions requirements; (3) you will pursue a full course of study; (4) you proved to us that you have enough money to study and live in the U.S. without working illegally or suffering from poverty.

You need a Form I-20 to obtain an F-1 Student visa or status, or to keep lawful F-1 status when transferring or changing schools within the U.S.

#### **DOES EVERYBODY NEED A FORM I-20?**

**NO, some international students do not need I-20's.** B Visitors and F-2 dependents must obtain an I-20 and apply for a change of status to F-1 student to pursue a course of study that is not avocational or recreational in nature. If you are maintaining another nonimmigrant status in the U.S., you do not have to have an I-20 and may attend school full- or part-time. Dependent children in E, H, I, J, L, M, N, O, P, R, or S status need to change status after their 21<sup>st</sup> birthday or if they marry.

#### THESE ARE THE RULES FOR GETTING YOUR FORM I-20

- 1. YOU MUST BE A "BONA FIDE" (REAL) STUDENT, ACCEPTED TO ONE OF THE ART STUDENTS LEAGUE'S FULL-TIME CERTIFICATE PROGRAMS: FOUR-YEAR FINE ARTS PAINTING, FOUR-YEAR FINE ARTS PRINTMAKING, OR FOUR-YEAR FINE ARTS SCULPTURE.
- 2. YOU MUST <u>PROVE</u> TO US THAT YOU CAN SUPPORT THE COSTS OF LIVING AND STUDYING IN THE U.S. FOR <u>EVERY YEAR</u> OF YOUR CERTIFICATE PROGRAM WITH THE ART STUDENTS LEAGUE. THIS IS REQUIRED BY THE U.S. GOVERNMENT IN ORDER TO ISSUE THE FORM I-20.
- 3. DO NOT EXPECT THAT YOU WILL BE ABLE TO WORK IN THE U.S. TO HELP MEET YOUR ANNUAL COSTS! On-campus employment is limited; off-campus employment is strictly controlled by the U.S. Department of Homeland Security.
- 4. CAREFULLY REVIEW OUR SCHOOL'S "ESTIMATED ANNUAL COSTS FOR INTERNATIONAL STUDENTS" ON PAGE SEVEN AND FIGURE OUT "YOUR ESTIMATED ANNUAL COSTS" IN THE WORKBOX ON PAGE EIGHT. THIS IS THE AMOUNT THAT YOU MUST PROVE THAT YOU CAN SUPPORT FOR EVERY YEAR IN YOUR PROGRAM OF STUDY. (Estimate that it will take four years for a certificate of completion in Fine Arts Painting, Printmaking, or Sculpture.)
- 5. THESE REQUIREMENTS ARE NOT NEGOTIABLE. They represent a modest average budget that does not include luxuries of any kind. We strongly recommend that you budget at least 10% more if possible. Too little money causes pain and distress. Students and their families should look closely at the costs of living in New York City and studying at The Art Students League's Certificate Program and make careful plans to ensure your needs will be met.
- **6. EXPECT** <u>ANNUAL</u> **INCREASES** *in tuition and living costs of approximately 10%.*
- **7. SOMETIMES, WE MAY HAVE TO ASK YOU TO GIVE US MORE PROOF OF YOUR FUNDING** perhaps more than once. The U.S. government requires that we be sure, to the best of our ability, that you will have enough financial support during your stay.

#### THESE ARE THE INSTRUCTIONS FOR GETTING YOUR FORM I-20

- 1. COMPLETE THE APPLICATION FOR A FORM I-20 (pages 9-12)
- 2. IF APPLICABLE, HAVE YOUR SPONSOR(S) COMPLETE THE SPONSOR'S AFFIDAVIT AND ATTACH THE REQUIRED EVIDENCE. (pages 13-16)
- 3. SUBMIT YOUR APPLICATION FOR A FORM I-20, EVIDENCE, AND SPONSOR'S AFFIDAVIT TO US VIA EMAIL TO <a href="mailto:ewang@artstudentsleague.org">ewang@artstudentsleague.org</a>. DO NOT SEND US ORIGINALS. KEEP THE ORIGINALS TO TAKE TO YOUR VISA INTERVIEW.
- 4. WE STRONGLY RECOMMEND THAT YOU SUBMIT YOUR I-20 APPLICATION, EVIDENCE, AND SPONSOR'S AFFIDAVIT AT THE SAME TIME AS YOU ARE APPLYING TO THE LEAGUE'S CERTIFICATE PROGRAM. THAT WAY, IF YOU ARE ACCEPTED, YOUR FORM I-20 CAN BE ISSUED.

#### **FUNDING SOURCES**

#### YOUR FUNDING CAN COME FROM ANY COMBINATION OF SOURCES IN THE U.S. OR ABROAD:

1. <u>FUNDS FROM "SPONSORS"</u> (parents, relatives, friends, organizations). You may have as many sponsors as you need. Sponsors may provide you with support in the form of money and/or room and board. Free room and board is when you live with someone and don't have to pay for your room or food.

#### WARNING!

It is highly recommended that at least part of your financial support come from your home country. This helps when you apply for your student visa!

#### WARNING!

A sponsor should promise only as much money as he or she is <u>capable</u> of giving you. Some sponsors believe that the more money they promise the easier it will be to get your I-20. THE MOST COMMON REASON WE REJECT FINANCIAL DOCUMENTS IS THAT WE DO NOT BELIEVE THE SPONSOR CAN AFFORD TO GIVE AS MUCH MONEY AS PROMISED. A sponsor should promise only what he or she intends to give and only as much as can be afforded.

- 2. <u>PERSONAL FUNDS</u> come from <u>your own</u> resources, not those of anyone else. If your parents put money in your bank account, we will ask you to submit the evidence required of sponsors. Unless you have enough cash to support yourself for your entire program of study or can prove other sources of personal income, you will need a sponsor with an income sufficient to support you.
- **3. FUNDS FROM THIS SCHOOL** Not all Art Students League support covers the entire program of study or all expenses, so you will need additional support to meet your minimum annual costs.

#### **EVIDENCE REQUIREMENTS**

COMPLETE THE APPLICATION FOR THE FORM I-20 (attached) AND SUBMIT IT WITH ALL THE REQUIRED EVIDENCE OF FUNDING DIRECTLY TO THE INTERNATIONAL STUDENT SERVICES OFFICE VIA EMAIL TO <a href="mailto:ewang@artstudentsleague.org">ewang@artstudentsleague.org</a> (DO NOT MAIL US ORIGINALS; KEEP THEM FOR YOUR VISA INTERVIEW)

#### **ALL DOCUMENTS YOU GIVE US MUST BE:**

- 1. Less than two months old.
- 2. In English. (We cannot review documents that are not in English!)

#### **EVIDENCE REQUIRED:**

#### **SPONSORS OF CASH SUPPORT:**

1. **SPONSOR'S AFFIDAVIT AND EVIDENCE OF ANNUAL CASH SUPPORT.** This form may be copied for each sponsor. <u>All</u> questions must be answered.

#### 2. PROOF OF INCOME.

#### **Individual Sponsor:**

- Income tax returns or receipts
- Pay stubs for last six months
- Bank/investment statements for the last six months

#### **Company Sponsor:**

- Business registration
- Licenses
- Profit and loss statement
- **3. BANK STATEMENT in the name of the sponsor** *only*. A monthly statement of balances and deposits. Letters from bank officials will not be accepted in lieu of statements.

#### WARNING!

If there is no proof of income provided with a bank statement, the statement balance will be totaled and divided by the number of years in your program of study to determine the amount available to you for each year.

#### WARNING!

The income of a company *is not* the personal income of the owner of the business and will not be accepted as proof of income. The owner/sponsor must still provide proof of personal income.

#### WARNING!

If a bank statement is in the name of more than one person, each individual must submit an affidavit of support.

#### WARNING!

We cannot accept bank statements that do not specify monthly balances and deposits!

#### **SPONSORS OF FREE ROOM AND BOARD:**

- 1. SPONSOR'S AFFIDAVIT AND PROOF OF FREE ROOM AND BOARD
- 2. PROOF OF INCOME: Any of the following with most recent pay stub:
  - Income tax returns or receipts;

  - Bank/investment statements for the last six months
- 3. COPY OF PROPERTY LEASE, DEED, RENT RECEIPTS, OR UTILITY BILL

#### WARNING!

If you are presently in the U.S., you must be living with the sponsor at the time of filing this application for this to be counted towards your means of support.

#### SPONSOR'S AFFIDAVIT AND EVIDENCE OF ANNUAL CASH SUPPORT

#### WHAT DOES THIS AFFIDAVIT MEAN?

- Attach the supporting evidence listed below. The affidavit will not be accepted without the required supporting evidence.
- Give the student the original documents and have him or her submit them electronically or make photocopies to mail or fax to us with the application for a Form I-20. The student will need to keep the originals to present to the consul at the visa interview.

#### WHAT DOES THIS AFFIDAVIT MEAN?
